**PREPARATION:**

Sweep area to be repaired. Be sure to remove all loose material.

**Prepare barra el polvo y desperdicios-remueva todo el pavimento suelto.**

**PLACEMENT & COMPACTION:**

NOTE: Product may become compressed during shipping but this does not affect product quality. If product stiffens in the bag, roll the bag over a hard surface to loosen product to potting soil consistency.

Fill area with SAKRETE U.S. COLD PATCH to a height that is 25% higher than depth. For patches deeper than 2 inches, apply in layers.

**Aplique bacie la bolsa en el hoyo-nivelelo 25% mas alto que la profundidad del parche.**

Compact with a tamper, a shovel or by driving over the area with the wheels of your car. Return any unused product to bag and store for future use.

**Comprima enteramente con un pizon pala o manejando sobre el parche.**

For repairs over 2" deep, it is very important to apply this material in 1-2" lifts (layers). Pour some material into the hole, compact it with a post or tamper and repeat until the area is repaired. Finished patch should be slightly crowned above surrounding surface. **Para reparaciones de mas de 2" de espesor, es muy importante aplicar este producto en tongadas (capas) de 1-2". Coloque parte del material en el bache (hoyo), compactelo con un poste o apisonador. Repita esta operacion hasta terminal de reparar el area.**
